CALL FOR A NEW HUMAN RIGHTS LAW – your support needed!



Our JPSR newsletters always include an 'action'. This month's is simple – **please sign this petition**, and maybe pass it on to family and friends too?

It is being run by **Traidcraft Exchange** who are campaigning for a **new human rights law**.

People can still walk into UK shops and buy a product that was partly made through slavery or child labour or some form of harm such as deforestation. That could be a mobile phone, clothing or shoes, carpets, jewellery, chocolate spread, fireworks – many, many diverse items. We shouldn't be able to buy these things. Our current laws are not good enough to stop it.

So Traidcraft are calling for a new '**Business and Human Rights Environment Act**' to avoid causing harm anywhere in the supply chain. It's a massive undertaking and it's supported by over 30 different organisations, including CAFOD and Action Aid. The petition has already been tabled in Parliament. The European Union has put down a proposal to make this EU wide. This strengthens the case for it happening in the UK, because we wouldn't want to fall behind the EU. By 2024, it is hoped that a commitment to pass the law will be included in every political party manifesto.

The Act will require businesses to prevent abuses from occurring, punish companies if abuses take place, compensate victims and where possible clean up and restore the damage caused.

Campaigning works if enough people get behind it – St. Joseph's parishioners, we call on you now to do your bit, please.

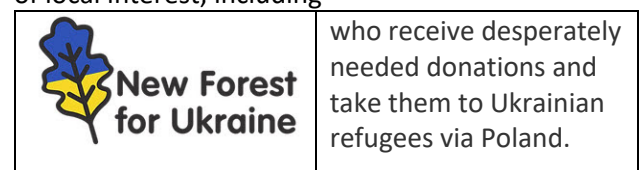
